Proxy voting is not permitted and hence will not be allowed.

For preparation of the electoral college of TNSKA, all Member State and UT units are requested to send two names of their representatives, duly signed both by the President and the General Secretary on or before 07/09/2026 to the undersigned by email at tamilnadustatekickboxing2014@gmail.com. In case different names are received from the President and the Secretary, the names sent by the President will be considered.

It has to be ensured by the District and UT units that only such members who are elected representative in the Governing Council of that unit are to be nominated.

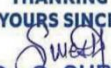
